CEGH DATA PROTECTION STATEMENT

Storage and processing of personal data acc. Regulation (EU) 2016/679 (General Data Protection Regulation) in the context of the provision of Hub services and CEGH membership resp. CEGH REMIT platform

Central European Gas Hub AG (CEGH) is responsible for storage and processing of personal data in accordance with Art. Regulation (EU) 2016/679 (General Data Protection Regulation) in the context of the provision of Hub services and the CEGH membership or CEGH REMIT platform.

CEGH processes and stores personal data in connection with the fulfillment of its contractual obligations as the operator of the Virtual Trading Point pursuant to § 68 Austrian Gas Act 2011. Legal basis for processing the data is the CEGH Membership Agreement AB B-VHP resp. the Terms of Use of the CEGH REMIT Platform in their respective currently valid version.

For the purpose of concluding and fulfilling the CEGH Membership Agreement as well as fulfilling the regulatory requirements regarding the activity as Balance Group Responsible Party or Virtual Trader or for the use of the CEGH REMIT platform, the necessary personal data are processed:

Name, contact details, data concerning the respective contractual relationship (e.g., e-mail address, telephone number, nomination data, data regarding the deposited security, officials / organs, commercial register data, account and credit information, information from rating agencies, etc.), communication in the context of the provision of Hub Services and the CEGH membership as well as the use of the CEGH REMIT platform.

For the purpose of processing, personal data might be transmitted to Energie-Control Austria (<u>www.e-control.at</u>), ACER (<u>www.acer.europa.eu</u>, Austrian Gas Grid Management AG (in their capacity as Market Area Manager for the Austrian Market Area East; <u>www.aggm.at</u>), to PEGAS CEGH Gas Exchange Services GmbH (<u>www.cegh.at</u>), to Powernext SAS (<u>www.powernext.com</u> as well as to IT service providers. Likewise, personal data may also be transferred to CEGH by the named bodies if this is necessary for the conclusion or the fulfillment of the CEGH membership contract or of any regulatory requirements regarding the activity as Balance Group Responsible Party or Virtual Trader.



Data are stored for the period of the existence of an upright contractual relationship as well as for the duration of the existence of legal claims concerning the contractual relationship or the corresponding regulatory requirements.

With regard to the data stored by CEGH, you have the right to information, correction, deletion, restriction, data portability as well as revocation and objection at any time. Possible consequences of not providing the necessary data are that a conclusion or the fulfillment of the CEGH Membership Agreement is not or only to a limited extent possible.

Your consent to data processing can be revoked at any time, indicating that data processing remains legal until the time of withdrawal.

If you believe that the processing of your data violates data protection law or if your data protection claims have otherwise been violated in any way, you can lodge a complaint with the supervisory authority. In Austria, this is the data protection authority.
